## TERMS OF SERVICE FOR USE OF SAUTI YA BAJETI PLATFORM

These Terms of Service ("Terms") govern your use of the Sauti Ya Bajeti platform ("Platform"), an AI-powered WhatsApp chatbot operated by the **Institute of Public Finance (IPF)**. By accessing or using the Platform, you acknowledge that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, please refrain from using the Platform.

## 1. Acceptance of Terms

## 1.1 Binding Agreement

By using the Platform, you enter into a binding legal agreement with IPF regarding your use of the Platform and all related services. This agreement supersedes any prior communications or agreements, whether electronic, oral, or written, regarding the Platform.

#### 1.2 Modifications

- Opportunity for IPF and its partners to share information on related work
